SUBJECT: Update on Activities Since the January 2025 Board of Trustees Meeting

#### **EXECUTIVE SUMMARY:**

This Staff Report is intended to report the noteworthy activities and events of the District. Noteworthy activities from January 2025 is provided below:

    - Pump testing complete. Capacitor bank installation has commenced, which is necessary for PG&E to connect permanent power, expected completion is April 2025. Temporary power for the motor heaters has been complete.

 Pump #5 is non-operational due to shorted conductors from the motors to the MCC cabinets, repairs will be performed as time becomes available. Plant capacity is at 90%.

## a. CIP Update

i. KSN is working on a final design concept and project phasing for Pumping Plant #8. An offer has been made to the property owner adjacent to Pumping Plant #8, discussions are currently underway to determine the next steps forward. The final design is expected to be completed by July 2025.

#### a. MAP (Metro Air Park)

- Reviewed updated drainage study and modeling reviewed by Mark Kubick. Identified I-5 culvert impacts for review of proposed WSEL raise north of I-5 (floodplain mapping incomplete). Downstream improvements mainly influenced by new pump at Plant 3. Additionaly, L Drain widening south of Interstate 5.
- ii. Reviewed with Sac County on 6/14/24, comments provided to Wood Rodgers/MAP on 6/19/24.

## b. <u>Upper West Side</u>

- i. A new SMUD plan has been submitted, the plan is to reroute facilities, utilizing existing lines to the east and north along the East Drainage Canal.
- ii. Drainage Study comments final review completed with Wood Rodgers & County on 05/23/2024.
- iii. Met with SMUD at locations along the East Drain related to pole placement.
- iv. Wood Rodgers responded to RD1000 comments on Financing Plan on 9/24.

## c. Sutter Pointe

- i. CVFPB permit application for the Sewer main crossing has been endorsed.
- ii. Currently reviewing associated submittals.

## a. Basin-wide Hydraulic Model

- iv. FEMA has no issue with RD1000 leading the review separate form future Map revisions by City/Counties.
- v. Hydrology report was submitted to FEMA on 08/21/24, mapping will be updated based on final hydrology report.
- vi. Met with FEMA for the Sutter County mapping on 8/21/24.
- vii. FEMA hydrology comments received on 12/19. Mainly reporting clarifications, without significant model changes. Further clarification is needed on Sankey Gap and PGCC inflows into basin, coordinating with SAFCA (MBK) as this is the source of inflow data.

## f. SYSTEM-WIDE IMPROVEMENT FRAMEWORK (SWIF)

i. The SWIF was approved on September 16, 2024.

#### 6. Natomas Levee Improvement Projects

The Corps continues to work with the State and SAFCA on borrow for the project. The Corps is evaluating needs for each Reach and available sources to minimize delays and maximize efficiency.

The Corps completed their flood risk assessment for the remaining contracts in Reach E, F, G, Pump Plant 5, Highway 99 and Reach I contract 2.

#### a. Reach A

- The Contract was awarded in September 2021 to Ahtna-Great Lakes (joint venture) for the base contract levee work. The second construction has commenced.
- ii. Cutoff Wall and utility relocaitons in progress.
- iii. SAFCA/State continue coordinating with the Corps on SMUD, AT&T and PGE relocations which are underway. The team is also working with the City of Sacramento on waterline and service connections along Garden Highway.
- iv. The contractor has demobilized for the duration of this years flood season.

## b. Reach D

- i. The reconstruction of Pumping Plant 4, along with the discharge pipes and outfall structure, is largely complete. A meeting was held on 8/5/24 to discuss the capacitor bank design, which is necessary to meet PG&E's voltage drop specifications for a permanent power connection.
- ii. Capacitor bank installation has commenced, expected completion is April 2025.

iii. The Corps is working on the package to turn the previously completed levee improvements in Reach D over to the non-federal sponsors (and RD 1000) though the District has effectively taken over the O&M of the levee.

## c. Reach E

- i. PG&E relocations are complete, AT&T service pole relocations are in progress. Levee grading work, SB cutoff wal, working platform and culvert underdrain tie-ins are in included in this project.
- ii. SAFCA has acquired all the right of way for construction and utility relocations and has physical possession of the property.
- iii. The contractor has demobilized for the duration of this years flood season.

## d. Reach F

- i. Final design documents completed by USACE.
- ii. Critical issues include right of way acquisition (some which require relocations); relocation of existing WAPA tower (lead time for relocation more than a year); utility relocations and borrow source.
- iii. Levee construction award is scheduled for 2024 with construction in 2025 and 2026. Ongoing coordination with easements, O&M features and Pumping Plant #6 work.

## e. Reach G

i. See notes above for Reach F as Reaches F and G are combined into a single design and construction contract.

## f. Reach I

- i. Construction of the cutoff wall has been completed and project finalization and turnover to SAFCA and the District is in progress. A final construction report has been submitted for SAFCA and the District to review.
- ii. Design for the Reach I Contract 2 to construct a patrol / maintenance road and perform levee slope flattening has been completed. SAFCA is working on real estate acquisition and coordination with utilities for relocation. All tree removal has been completed. Letter of Acceptance sent to SAFCA. O&M manual was provided by the USACE

#### g. Hwy 99/NCC Cutoff Wall

i. Construction expected June-October 2025, however 90% of the geotechnical drilling is complete.

## h. Other Projects

- i. Plant 5 replacement—The Corps has awarded the design contract to the Stantec/Kleinfelder team. The new pumping plant will be located approximately 400 feet east from the current location. The Corps is working with the State, SAFCA and RD 1000 to close out comments from the 100% plans. The current schedule is for construction in 2025.
- ii. West Drainage Canal Relocation The West Drainage Canal will realign the westernmost portion of the canal and reshaphe approximately 11,000 LF of the existing channel. This will improve drainage in the area, stabilize bank slopes, which will reduce bank sloughing and improve water quality. The improvements will construct habitat to promote migration of the Giant Garter Snake. The realigned portion is an attempt to reduce bird strikes between incoming and outgoing aircraft from SMF. This project is currently at the 35% design phase, with an anticipated start date in 2028.

#### **EXECUTIVE SUMMARY:**

This Staff Report is intended to inform the Board and serve as the official record of the activities the District's field staff engaged in for the month of January 2025. Additionally, District staff repaired numerous washouts along the North Drainage Canal. Moreover, tree trimming was conducted along the Main Drainage Canal to help mitigate potential utility outages. Meanwhile, the replacement of trash rake drums is underway and is expected to be completed by February 12.

The Operations Manager's report was created to provide monthly updates to the Board of Trustees on field-related activities within the District boundaries, as well as provide a historical record. This allows for the District and the public an opportunity to refer back to data trends over time regarding the weather impact on District facilities, crew activities, and local river and canal conditions as well as general District activities from month to month.







# Verona River Levels:







## 4.1. GENERAL MANAGER'S REPORT:

#### Acquisition of Property for Plant 8 Reconstruction

General Manager Kevin King reported that negiotiations are still active for the acquisition of property for pumping plant 8.

#### Capital Improvement Plan (CIP) Update

Trustee Lee Reeder inquired about the progress made toward the existing CIP and whether it was time for the district's plan to be updated. GM King shared that it has been five years since the last update, so he will look to update portions of the previous CIP plan and revisit project priorities.

Trustee Lee Reeder requested a working timeline for CIP improvements to keep updated and to inform the community of our progress. She also asked that smaller projects (like track rake replacement) be added to the timeline to track status and completion.

Trustee Avdis voiced support for revisiting the CIP and priorities sooner rather than later.

GM King will budget for the requested CIP update work next fiscal year. He will work with the Operations Committee to create a five-year project timeline.

Trustee Smith emphasizes that improvements are for the future but understands that some of our infrastructure is old and will eventually fail.

GM King commented that the Stormwater Fee ensured the district no longer operates in run-to-failure mode. He noted that he will implement a plan, complete pre-engineering work, and capitalize on grant funding opportunities.

GM King believes the district is in a good spot, has made significant progress toward preventative maintenance programs using the CIP budget, and notes that we are on the cusp of some pretty big projects.

Trustee Bains inquired about whether construction of Plan 8 would begin this year. GM King stated that we would have to phase work over several flood seasons, but he is hopeful the generator portion at Plant 8 will be covered this year by \$4 million in federal appropriation funding. If the appropriation goes through, he will immediately purchase the generators, which may take up to a year for delivery.

#### 4.2. OPERATIONS MANAGER'S REPORT:

Operations Manager Gabe Holleman spoke about the new switchgear installation at Pumping Plant 2, a significant step forward, which has been commissioned and is fully operational. This plant, which previously had one pump down, is now fully functional, improving operations on the district's northern end, near the airport.

#### 4.3. DISTRICT COUNSEL'S REPORT:

District Counsel Rebecca Smith reported a quiet period with routine tasks ongoing. A key focus was a meeting with county staff on improving election processes amid confusion caused by staff turnover. A plan to streamline future elections will be discussed.

General Manager Kevin King provided an update to the legal report. The district denied Brookman Security Services' claim last month but is reviewing the latest information received from their attorney. A meeting with legal counsel is scheduled to address this and another matter concerning the warehouse. Updates will be presented to the Board in February.

#### **EXECUTIVE SUMMARY:**

This Staff Report aims to inform the Board of the current total funds in the District's checking and money market accounts, Sacramento County Treasurer Fund, State Treasurer Local Agency Investment Fund (LAIF), and the City of Sacramento Pooled Investment Fund.

The attached report provides monthly beginning and ending balances for operations and maintenance cash flow. It includes the current month's receipts, fund-to-fund transfers, accounts payable, and payroll. The Treasurer's Report also features notable fund and cash flow items for January 2025.

The District maintains funds in the California State Controller Local Agency Investment Fund (LAIF), the Sacramento County Treasurer, and River City Bank. In the fiscal year 2024-2025, the District will primarily rely on levied property assessments and the newly approved Stormwater Fee for its income. Sacramento and Sutter County property tax bills collect these assessments and fees.

The Board of Trustees approves a resolution annually that designates officers and signatories to the Operations and Maintenance Fund held by the Sacramento County Treasurer. The District's Financial Reserve Policy guides current, future, and unexpected funding requirements. In contrast, the District's Investment Policy guides investments made by the District of any surplus or reserve funds it may have.

#### **EXECUTIVE SUMMARY:**

The Budget to Actual report provides a monthly snapshot of how well the district meets its budget goals for the fiscal year. The monthly report contains a three-column presentation of actual expenditures, budgeted expenditures, and the budget percentage. Each line item compares budgeted amounts against real-to-date expenses. Any significant budgeted line item variances will be detailed below.

Attachment 1 provides a report for the month ending January 2025. The most significant administrative expenditures include accounting/audit, mitigation land expenses, property taxes, and annual memberships. The most significant operations expenditures include power, supplies and materials, equipment repair, FSRP grant prepays, utilities, and temporary administration.

#### **BACKGROUND:**

Annually, the Board of Trustees adopts the district's annual budget in June. Typically, three board committees review the draft budget prepared by staff. The Personnel Committee reviews the wage and benefits portion of the budget. The Operations Committee reviews the Capital expenditures Budget. After the two committees review and make recommendations regarding the budget, the final draft is prepared for the Finance Committee to consider. After review by the Finance Committee, the final Proposed Budget is presented to the entire Board for review and thirty days later for adoption at a regular Board meeting.

#### **RECOMMENDATION:**

Staff recommends the Board review and accept the Budget to Actual Report for January 2025.

TITLE: Investment Report

SUBJECT: Monthly District Investment Report – January 2025

#### **INTRODUCTION:**

The Monthly Investment Report informs the Board of the District's investment activity to ensure alignment with the District's Investment Policy, focusing on "Security, Liquidity, and Yield."

The monthly investment reporting lags by one month due to the release timing of monthly yields for all investment accounts.

#### **EXECUTIVE SUMMARY:**

#### 1. Investment Holdings Summary:

The District holds investment funds in Sacramento City Pool A, Sacramento County Treasury, LAIF, California Class, and River City Bank.

#### 2. Performance Metrics:

City Pool A distributes the lowest yield during this reporting period and the second-highest fee structure at .26% basis points. The Pool's most recent monthly yield reported is 2.730% for December 2024.

Sacramento County Treasury's most recent reporting yield is for December 2024 at 4.254%. The County Treasury maintains the third-lowest management fee structure at .06% basis points.

LAIF distributed a monthly reporting yield of 4.366% in January, lower than the previous month's 4.434%. LAIF has the highest monthly management fee structure at .34% basis points.

The California Class monthly yield for January is 4.421%, down from 4.634% the previous month. CA Class offers a steady 0.1% management fee.

River City Bank's monthly yield remains steady at 4.99%, the highest investment yield the District receives with zero management fees.

#### 3. Compliance and Policy Adherence:

The District's investments adhere to the District's investment policy.

The District invests in the County Treasury, LAIF, and Sacramento City Pool. Additionally, the District holds funds in stable money market accounts with California Class and River City Bank.

#### **RECOMMENDATION:**

Staff recommend that the Board review the attached Investment Report. Economic conditions should continue to be closely monitored.

At a regular meeting of the Board of Trustees of Reclamation District No. 1000 held at the District Office on the 14<sup>th</sup> day of February 14, 2025, the following resolution was approved and adopted:

**WHEREAS,** the Reclamation District No. 1000's (District) mission is flood protection for the Natomas Basin providing for the public's health and safety by operating and maintaining the levees, and the District's canals and pump stations; and

**WHEREAS,** the Board of Trustees ("Board") of Reclamation District No. 1000 ("District") is a reclamation district created by act of the legislature of the State of California, approved April 8, 1911; and,

**WHEREAS**, the Sacramento Area Flood Control Agency ("SAFCA") a joint powers authority formed pursuant to Government Code section 6500, *et seq*. of the State of California; and,

WHEREAS, the District and SAFCA are collaborating with the U.S. Army Corps of Engineer's ("Corps") on completion of the Natomas Levee Project improvements ("Project"); and,

This agreement (Agreement) is entered to on this \_\_\_\_ day of \_\_\_\_\_\_\_\_, 2025 between the Sacramento Area Flood Control Agency, a joint powers authority formed pursuant to Government Code section 6500, et seq. (SAFCA or Government) and Reclamation District No. 1000, a California Reclamation District organized and existing under California Water Code section 50000 et seq., with its principal office and place of business in the City of Sacramento, State of California (Owner or District).

WHEREAS, the Government has, as contemplated by Section 7002(2)(2) of the Water Resources Reform and Development Act of 2014 (Pub. L. No. 113-121, § 7002(2)(2), 128 Stat. 1193, 1366 (2014)) and the Project Partnership Agreement entered into by SAFCA, the State of California acting by and through the Central Valley Flood Protection Board (CVFPB), and the U.S. Department of the Army, represented by the Assistant Secretary of the Army (Civil Works), acting through the U.S. Army Corps of Engineers Sacramento District (USACE), undertaken the development of a project known as the American River Watershed, Common Features Project, Natomas Basin (Project) together with the USACE; and

WHEREAS, the Owner is the holder of certain easements or fee interest land rights on which Owner has constructed and is operating and maintaining an existing interior drainage system and in particular a storm drain pump station located adjacent to the levee operated and maintained by Owner and identified for purposes of the Project as Pumping Plant No. 5 (PP5) referred to as the "Facility"; and

WHEREAS, operation, maintenance, and performance of the Facility will be directly impacted by the construction, operation, and maintenance of said Project necessitating alteration, relocation, rearrangement and/or modification (Alteration) of Owner's Facility; and

WHEREAS, the permits and regulatory approvals under which Owner's Facility operate allow for the relocation of the Facility if necessary to facilitate a flood control project; and

WHEREAS, Owner is willing to permit access to, and use of, its Facility by the Project in consideration of the Alteration of its Facility by Government as set forth herein, through

the USACE and its independent contractors; and the Owner agrees that such consideration constitutes full, just, and complete compensation for the acquisition through Alteration by Government, through the USACE and its independent contractors, of Owner's rights and property.

NOW THEREFORE, in consideration of the faithful performance of each party of the mutual covenants set forth herein, it is mutually agreed as follows:

#### ARTICLE 1. Obligations of the Owner.

- (a) Owner agrees that the altered Facility, as portrayed in the final drawings, schedules, plans, and/or specifications ("Specifications") used by USACE to award a contract to its independent contractor for Alteration of the Facility, with said Specifications hereby incorporated herein by reference and which were previously approved by Owner, shall constitute an adequate substitute for the existing Facility, the Alteration of which is the result of the construction, operation, and maintenance of the Project.
- (b) In order to accomplish the Alteration of Owner's Facility affected by the construction, operation, and maintenance of the Project, the Owner hereby grants to the Government, its agents, assigns, employees, contractors or subcontractors, including but not limited to the USACE, its employees and its independent contractors, and the CVFPB, without further consideration, an irrevocable license for the Term identified above, for the design and construction of the Alteration on the property and easement(s) held by the Owner and/or Government in the areas depicted on Exhibit "A" attached hereto (the "Site"). This irrevocable license is limited to the portions of the above-identified APNs labeled TWAE Area on the attached Exhibit "A" for the term and uses stated above and does not include the right to pass over property not belonging to or under the control of Owner. Government shall obtain any necessary approvals from other landowners or regulatory agencies.

ARTICLE 2. Obligations of the Government.

Subject to the availability of funds, the Government shall:

- (a) Alter the existing Facility as provided in the Specifications.
- (b) Furnish, subject to the conditions herein, all services, labor, materials, tools, equipment, permits and licenses necessary and essential to the Alteration of the Facility, which Government has arranged to be performed by the USACE and/or its independent contractors, in accordance with federal law and federal acquisition regulations.
- (c) The Government, through the USACE and its Contracting Officer shall ensure the Facility or the temporary pumping and bypass system described below is fully functional during the flood season of November 1 through April 15 for the duration of the construction, unless otherwise agreed to by the Owner. The temporary pumping and bypass system shall consist of two temporary pumps each at 7,500 gallons per minute. The Government, through the USACE and its Contracting Officer, shall require that materials necessary for the temporary pumping bypass system including, but not limited to, pumps, motors, electrical components and discharge piping are

- either on site or at the USACE independent contractor's local corporation yard or otherwise procured to the satisfaction of the Owner by October 1 of each year of its planned use.
- (d) Furthermore, the Government, through the USACE and its Contracting Officer shall require that approval of submittals for all equipment necessary for the Alterations to PP5 including, but not limited to, pumps, motors, electrical equipment, and discharge piping are completed within one (1) year of the Notice to Proceed issued by the USACE and its Contracting Officer to their independent contractor, unless otherwise agreed to by the Owner.. To the extent possible, the Government shall afford the Owner the opportunity to review and comment on submittals and all proposed contract modifications, including change orders, that relate to or may affect the Alteration of the Facility.
- (e) Government shall provide reasonable access for District personnel, vehicles, and equipment during construction of the Alterations, as provided in the USACE construction contract, to allow for the Owner to conduct its operation and maintenance responsibilities, including operations of the pumping plant facilities and adjacent levee not under active construction. Owner agrees the terms the USACE construction contract as modified by this agreement are sufficient to meet Owner's operation and maintenance responsibilities.
- (f) Government agrees to exercise reasonable care to avoid damage to Owner's real property and shall repair any damage caused by Government, its agents, assigns, employees or subcontractors as directed by the Owner, including but not limited to any damage that is not the responsibility of the USACE and/or its independent contractors as determined by the USACE Contracting Officer. Upon completion of the work for which this Agreement was executed, Government shall fully restore the Owner's real property to its pre-project condition to the reasonable satisfaction of the Owner, except for the Alteration to the Facility approved by Owner under the Specifications.
- (g) Fuels, lubricants or other hazardous materials brought on the Site shall be stored in suitable containers within a designated, double containment facility.
- (h) Owner is not responsible for any damage to, or loss of equipment or materials brought to the Site for purposes of performance of the Alteration to Facility caused by vandalism with the exception of any Owner provided equipment or materials.
- (i) If Owner determines, within their sole reasonable discretion, that emergency conditions, beyond the control of the USACE and its independent contractors, necessitate that access to the Site be temporarily suspended or modified, Owner will promptly notify Government and the USACE Contracting Officer of the nature of the emergency conditions, the proposed changes to access (if any), and the Owner's intended reasonable actions to address the emergency. Upon receipt of written request from Owner, Government shall immediately remove or arrange for the removal of any encroachments necessary to allow for the Owner's emergency actions including, but not limited to, facilities, structures, approximate and materials as requested by Owner
- (j) Government hereby agree(s) to defend and indemnify and save and hold the Owner,

and its employees and the USACE and its employees, free and harmless from any damage, costs (including attorney's fees and courtcosts) or liabilities which may arise as a result of the exercise of this Agreement and License by Government, its agents, assigns, employees, contractors, or subcontractors, including but not limited to the USACE, its employees and its independent contractors.

(k) Government shall keep and maintain comprehensive general liability insurance, or maintain a self-insurance program, during occupation of the Site by Government, its agents, assigns, employees, contractors, or subcontractors, including but not limited to the USACE, its employees and its independent contractors, through the expiration of this Agreement and completion of Site restoration referenced in Article 2(e), above, and shall provide a certificate or letter thereof to Owner naming Owner as an additional insured on Government's insurance policy(ies) or self-insurance program. To the extent legally permissible under applicable law, including but not limited to the Federal Acquisition Regulations, Government shall arrange for the Owner to be named as an additional insured on general liability insurance policies maintained by any independent contractor of the USACE constructing the Alteration of Owner's Facility.

#### ARTICLE 3. Parties' Representatives.

- (a) Owner may assign representatives or agents to observe and to inspect the completed construction work as it progresses. Such representatives shall communicate only with the Government, who will engage the USACE and the USACE Contracting Officer. Owner my communicate directly with the USACE and USACE Contracting Officer with the concurrence of the Government.
- (b) Government, through the USACE, has appointed a Contracting Officer for the purpose of issuing instructions and entering into modifications pursuant to requirements for changes in drawings, schedules, and specifications previously approved by the Owner and USACE. Government shall consult with Owner on the proposed modifications. Owner shall provide its response in a timely manner so as not to delay USACE or its independent contractors.

#### ARTICLE 4. Salvage.

The Government, through the USACE and/or its independent contractors, shall use such materials, equipment, and supplies from the Facility existing as of the date of this Agreement as can be placed in the Facility to be altered hereunder unless otherwise described in the approved plans and specifications. Any materials, equipment, and supplies which the parties heretofore mutually agree cannot be used shall be removed from their original location, by the Government, through the USACE and/or its independent contractors, and shall become the property of the Government, the USACE and/or its independent contractors.

#### ARTICLE 5. Betterments.

The Owner agrees that the Alteration to be accomplished under this Agreement will provide the Owner with a Facility equal in service and utility to that now in existence and that if the Owner desires any improvement in design, construction, or capacity over and above what is required to provide a Facility of equal service and utility, such improvement shall constitute a betterment and will be paid for by Owner; provided however, that the term "Betterments"

will not be deemed to include more costly construction or design necessitated solely as a result of the Alteration. Furthermore, items of work included in the Specifications, as those documents may be modified from time to time or included following approval of the Contracting Office pursuant to Article 3 of this Agreement, shall not be considered Betterments.

#### ARTICLE 6. Ownership and Conduct of the Work.

- (a) The Facility constructed hereunder shall be the property of the Owner. The Owner shall be responsible for all materials furnished and work performed by it.
- (b) The Government may award other contracts for additional or other work on the same Project or in the same vicinity. Owner shall conduct its own operations reasonably, and in cooperation with any such work being performed by the Government, through the USACE and its independent contractors, and shall take reasonable care to fit its own work to that provided under other contracts as directed by the Government, through the USACE and the USACE Contracting Officer. The Owner shall not commit or permit any act which may interfere with the performance of any such work by the Government, through the USACE and/or its independent contractors.

#### ARTICLE 7. Interference.

The Owner agrees that so long as the Project is operated or maintained for the purpose as described herein, the Facility as altered pursuant to this Agreement shall not be further altered or modified except insofar is as necessary to perform normal operations and maintenance of the Project, nor other facilities constructed by Owner; so as to interfere with the operation of the Project.

#### ARTICLE 8. Inspection and Acceptance.

The Owner shall have the right to inspect the work to be performed hereunder by the Government, through the USACE and/or its independent contractors, at any time during its progress and to make final inspection upon completion thereof. Owner agrees that the USACE Contracting Officer is the only individual with authority to determine whether work is or was performed in accordance the Specifications which the Owner has previously approved. In the event the Owner has any objections as to the USACE contractor's compliance with the Specifications, Owner shall make its objections known to the Government, who will engage the USACE and the USACE Contracting Officer. It will be the responsibility of the Government, through the USACE Contracting Officer, to make any needed corrections in the Project to assure conformity with the Specifications previously approved by the Owner to the reasonable satisfaction of the Owner.

#### ARTICLE 9. Release.

The Owner agrees, on completion of the Alteration to Facility provided for in the Specifications and acceptance of said Facility by USACE from the USACE's independent contractors, to accept said substitute Facility as full, complete and just compensation for any and all damages and/or impacts that have been caused to the Facility altered and does hereby release the Government and the USACE and its employees from any and all causes of action, suits-at-law or equity or claims or demands, and from any liability of any nature whatsoever for and on account of any damages and/or impacts to said Facility altered hereunder. Owner

acknowledges and agrees that Owner has no recourse against the USACE and its employees, which are third-party beneficiaries of this Agreement with a right of enforcement of the terms of this Agreement as against Owner and Government, including but not limited to, this Article 9, entitled "Release".

#### ARTICLE 10. Completion.

Construction of the work to be performed under this Agreement shall commence approximately within thirty (30) days after Notice to Proceed was issued to the USACE independent contractor. Alteration of the Facility is estimated to be completed within the Term of this Agreement as shown above. Owner acknowledges that the failure to meet this timeline is not a material breach of this Agreement, and Owner has no right of action against Government, the USACE, its employees and/or the independent contractors of the USACE.

#### ARTICLE 11. Disputes.

As a condition precedent to a party bringing any suit for breach of this Agreement, that party must first notify the other party in writing of the nature of the purported breach and seek in good faith to resolve the dispute through negotiation.

#### **EXECUTIVE SUMMARY:**

Reclamation District 1000 (RD 1000; District) coordinated with SAFCA on implementation of the Natomas Levee Improvement Project (NLIP). Levee improvements along the Natomas Cross Canal (NCC) required relocation of the Natomas Central Mutual Water Company's (Natomas) facilities along the NCC. The work was completed by Natomas a number of years ago and included new pipelines above and over the District's North Drain Canal as well as a new discharge structure within the canal. The attached Easement Deed provides non-exclusive rights to Natomas to operate and maintain these water conveyance facilities while protecting the District's flood control responsibilities.

Staff recommends the Board review and consider adoption of Resolution No. 2025-02-02 authorizing the General Manager to execute an Easement Deed to Natomas Central Mutual Water Company for water conveyance facilities on the District's North Drain Canal.

#### **EASEMENT DEED**

FOR payment of one hundred dollars (\$100.00) and other good and VALUABLE CONSIDERATION, the receipt and adequacy of which of which is hereby acknowledged, RECLAMATION DISTRICT NO. 1000, a Reclamation District created by Act of the Legislature of the State of California ("RD 1000") hereby GRANTS and conveys to NATOMAS CENTRAL MUTUAL WATER COMPANY, a mutual water company established pursuant to the laws of the State of California ("NCMWC") non-exclusive rights of way and easements in the unincorporated area of the County of Sutter, State of California, (i) over, under, upon and across that certain real property described in Exhibit "A" and depicted on Exhibit "B", both attached hereto and made a part hereof (the "Pipeline Easement Area") for the purpose stated in Section 1, below, and (ii) over, under, upon and across that certain real property described in Exhibit "C" and depicted on Exhibit "D", both attached hereto and made a part hereof (the "Outfall Easement Area") for the purpose stated in Section 2, below.

1. Pipeline Easement. The Pipeline Easement Area is for an easement ("Pipeline Easement") for the conveyance of water through the Pipeline Easement Area, including the operation and maintenance, use, repair, construction, reconstruction and replacement of, and conveyance of water through three 72-inch diameter water conveyance pipelines (and all appurtenance thereto and components thereof) suspended above and across RD 1000's North Main Drainage Canal and ancillary supporting structures. Reconstruction or replacement of such water conveyance pipelines may be with more or fewer pipelines, and of a different diameter (smaller or larger) provided that prior to any such reconstruction or replacement, plans and specifications therefore are provided to RD 1000 for RD 1000's reasonable review and approval to ensure such reconstruction or replacement does not unreasonably interfere with RD 1000's operation and maintenance responsibilities of RD 1000's North Main Drainage Canal. Construction shall be coordinated with RD 1000 and shall not occur during the flood season of November 1 to April 15 unless otherwise

approved by RD 1000. Any such pipelines shall be maintained and repaired by NCMWC at its sole cost and expense (except for any damage thereto caused by RD 1000 or any of its agents, contractors or subcontractors) so as not to collapse into or unreasonably interfere with the operation and maintenance of the North Main Drainage Canal or otherwise impede flows in the canal. Any obstruction to flows in the North Main Drainage Canal caused by the pipeline crossings shall be removed and repaired immediately to the satisfaction of RD 1000 at NCMWC's sole cost and expense. RD 1000 agrees and acknowledges that the pipelines located within the Pipeline Easement Area, as presently constructed, do not unreasonably interfere with the operation and maintenance of the North Main Drainage Canal. The Pipeline Easement shall also allow for such incidental rights that are reasonably necessary for NCMWC's use and enjoyment of the Pipeline Easement, including but not limited to ingress and egress and temporary parking within the Pipeline Easement Area. RD 1000 reserves the right to limit such incidental rights due to adverse weather conditions, high canal levels or in an emergency at its sole discretion; however, RD 1000 will not unreasonably limit such incidental rights and shall remove such limitations as soon as reasonably practical.

- 2. Outfall Easement. The Outfall Easement Area is for an easement ("Outfall Easement") for the operation and maintenance, use, repair, construction, reconstruction and replacement of a concrete outfall structure (and all appurtenances thereto and components thereof) so as to capture spillage or excess water from the operation of the NCMWC water conveyance pipelines referenced in Section 1, above, and/or the connecting NCMWC Sankey Canal. Prior to any reconstruction or replacement of such outfall structure, plans and specifications therefore shall be provided to RD 1000 for RD 1000's reasonable review and approval to ensure, among other things, such reconstruction or replacement does not interfere with RD 1000's operations and maintenance responsibilities of the North Main Drainage Canal. Construction shall be coordinated with RD 1000 and shall not occur during the flood season of November 1 to April 15 unless otherwise approved by RD 1000. Such outfall structure shall be maintained and repaired by NCMWC at its sole cost and expense (except for any damage thereto caused by RD 1000 or any of its agents, contractors or subcontractors) so as not to interfere with the operations and maintenance of the North Main Drainage Canal or otherwise impede flows in the canal. Any obstruction to flows in the North Main Drainage Canal caused by the outfall structure shall be removed and repaired immediately to the satisfaction of RD 1000 at NCMWC's sole cost and expense. The Outfall Easement shall also allow for such incidental rights that are reasonably necessary for NCMWC's use and enjoyment of the Outfall Easement, including but not limited to ingress and egress and temporary parking within the Outfall Easement Area. RD 1000 reserves the right to limit such incidental rights due to adverse weather conditions, high canal levels or in an emergency at its sole discretion; however, RD 1000 will not unreasonably limit such incidental rights and shall remove such limitations as soon as reasonably practical.
- 3. <u>In Gross</u>. The easements granted herein are easements "in gross," benefiting NCMWC and its successors and assigns. The Pipeline Easement and Outfall Easement burdens the Pipeline Easement Area and Outfall Easement Area, respectively, and will be binding on each and every owner and successor owner thereof.
- 4. <u>Exclusivity.</u> Although the Pipeline Easement Area and Outfall Easement Area are not

exclusive to NCMWC, the right to convey water through the pipelines (as presently constructed or as hereinafter may be re-constructed from time to time) located in the Pipeline Easement Area, and the right to use the outfall structure located within the Outfall Easement Area (as such structure is presently constructed or as hereinafter may be reconstructed from time to time) are exclusive to NCMWC. Additionally, RD 1000 shall not construct or permit to be constructed within either the Pipeline Easement Area or Outfall Easement Area anything (including but not limited to any buildings or structures, or trees or plants with invasive roots) which would unreasonably interfere with NCMWC's use of the Pipeline Easement and/or Outfall Easement, including NCMWC's use of, maintenance, replacement, construction, reconstruction or access to the pipelines and/or outfall structure located therein.

- Access. NCMWC will have complete free and unimpeded access to the Pipeline Easement Area and Outfall Easement Area for reasonable construction, maintenance, monitoring, testing and related operational purposes except as noted below. To the extent reasonably necessary, RD 1000 hereby grants to NCMWC incidental rights of ingress, egress and temporary parking over other immediately adjacent portions of RD 1000's property for reasonable access to the Pipeline Easement Area and Outfall Easement Area and the uses described above. RD 1000 reserves the right to limit access and such incidental rights due to adverse weather conditions, high canal levels or during an emergency at its sole discretion; however, RD 1000 will not unreasonably limit such incidental rights and shall remove such limitations as soon as reasonably practical. The location of the right of ingress and egress shall be reasonably located so that it does not unreasonably interfere with the reasonable uses of RD 1000's property.
- 6. <u>Indemnification</u>. NCMWC shall remain responsible for any damage to the RD 1000 facilities as a result of this permitted encroachment. NCMWC agrees to save and hold RD 1000, its trustees, officers, employees and agents free and harmless from and to defend and indemnify them against any and all claims, including, without limitation, claims of personal injury or property damage, costs (including reasonable attorney fees), damages, liabilities and expenses arising as a result of the work authorized herein, including operations and maintenance, by any act or omission of NCMWC or its agents, employees or contractors.
- 7. <u>Default</u>. If NCMWC fails to perform its obligations under this easement deed or breaches the terms of this easement deed, RD 1000 shall have the right to give NCMWC a notice of default setting forth the nature of the default and stating that NCMWC shall have a period of thirty (30) days in which respond with a plan to cure the default within a reasonable period acceptable to RD 1000. Notwithstanding the foregoing, RD 1000 reserves the right to take reasonable actions necessary to protect its facilities and perform its public safety functions.
- 8. <u>Attorneys' Fees</u>. If legal action is initiated by any party hereto for the purpose of enforcing or interpreting this easement deed, the prevailing party or parties shall be entitled to recover from the losing party reasonable expenses, including reasonable attorney's fees, court costs and other legal costs.

- 9. <u>Termination</u>. This easement deed and the Pipeline Easement and Outfall Easement granted hereunder shall automatically expire upon the earlier of (A) NCMWC's abandonment of its facilities or non-use for a period of five (5) years with a 30-day written notice from RD 1000 of its intent to terminate, allowing NCMWC to demonstrate its facilities have not been abandoned and are still in use, (B) NCMWC notifies RD 1000 in writing of termination, or (C) the date NCMWC is no longer a going concern.
- 10. <u>Entire Easement Deed.</u> This instrument contains the entire easement deed between the parties relating to the rights herein granted and the obligations herein assumed. Any oral representations or modifications concerning this instrument shall be of no force and effect excepting a subsequent modification in writing, signed by both of the parties hereto. All exhibits hereto are incorporated herein by reference.
- 11. <u>No Waiver</u>. No waiver of any default shall be implied from any omission of a party hereto take any action with respect to such default, if such default is continuing or repeated. A waiver of any default hereunder shall not be deemed to be a waiver of any subsequent default.
- 12. <u>Severability</u>. If any provision of this easement deed is held to be illegal, invalid or unenforceable under any law, such provision shall be fully severable, and this easement deed shall be construed and enforced as if such illegal, invalid or unenforceable provision had never been comprised a part of this easement deed, and the remaining provisions of this easement deed shall remain in full force and effect and shall not be affected by the illegal, invalid or unenforceable provision, or by its severance from this easement deed.
- 13. <u>Binding on Successors.</u> The provisions hereof shall inure to the benefit of and be binding upon the parties and their respective successors and assigns into perpetuity.
- 14. <u>Counterparts.</u> This document may be executed in counterparts, which when taken together, shall be deemed to constitute one and the same document.




